

SL-2100 SEBS Skylight Coating

DESCRIPTION:

SL-2100 SEBS Skylight Coatings is a clear brushable elastomeric solvent based coating intended for waterproofing fiberglass roof panels and translucent skylights. SL-2100 is also an ideal sealant for decorative metal surfaces as well as gutters surfaces.

SUITABLE SUBSTRATES:

- Fiberglass Skylights
- Translucent Skylights

INSTALLATION INSTRUCTION:

SURFACE PREPARATION: The surface must be free of any oils, moisture, rust scale, soil or other contaminates that may interfere with good adhesion. Remove any loose material from seams or other surfaces with a wire brush or scraper. Oil and grease should also be removed with an appropriate cleaner. In many cases high pressure water blast will be sufficient to prepare the surface.

APPLICATION INSTRUCTIONS: Apply only when ambient temperatures are 50°F and rising, and substrate temperatures do not exceed greater than 130°F. For best spray application, the product should be at a minimum of 60°F. Lower temperatures can be utilized for brush/rolling applications. When exceeding 24-wet mils or using dark colors, the likelihood of blistering increases.

PRECAUTIONS:

PREVENTION: Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Wear protective gloves/clothing and eye/face protection. Wash face, hands and any exposed skin thoroughly after handling. Contaminated work clothing must not be allowed out of the workplace. Do not breathe dust/fume/gas/mist/vapors/spray. Use only outdoors or in a well-ventilated area. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Keep container tightly closed. Ground and bond container and receiving equipment. Use explosion-proof electrical/ ventilating / lighting/ equipment. Use only non-sparking tools. Take action to prevent static discharges. Keep cool. **RESPONSE:** Specific treatment (See Section 4 of this SDS). IF exposed or concerned: Get medical advice/ attention. Specific treatment (see .? on this label). IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eve irritation persists: Get medical advice/attention. If skin irritation or rash occurs: Get medical advice/attention. IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/ shower. Wash contaminated clothing before reuse. IF INHALED: Remove person to fresh air and keep comfortable for breathing. IF SWALLOWED: Immediately call a POISON CENTER or doctor. Do NOT induce vomiting. In case of fire: Use CO2, dry chemical, or foam to extinguish.

STORAGE & HANDLING PROCEDURES:

Store locked up. Store in a well-ventilated place. Keep container tightly closed. Shelf life is 24-months if stored in original unopened containers. Store between 45°F and 95°F. Do not heat with an open flame. All containers must be sealed when not in use. Wear protective gloves, protective clothing, eye protection, and face protection. If exposed or concerned: Get medical advice or attention. Clean equipment and any over-spray with AldoThinner.
